<b>Part II: Certification</b>	I, the undersigned State/official veterinarian certify that:		
	1.	Raw materials of animal origin, contained in the product, are obtained from clinically healthy animals slaughtered and handled in establishments, approved/registered by the competent authority in the EU and operating under its supervision.	
	2.	Raw materials of animal origin (meat and edible offal, fish and other marine products, egg products, milk and dairy products, honey, fats), contained in product, are declared fit for human consumption.	
	3.	Raw materials from bovine, ovine and caprine animals comply with the relevant legislation for the prevention, control and eradication of certain transmissible spongiform encephalopathies of the EU.	
	4.	The products derive from establishments or cold stores not under restrictions with regard to contagious diseases relevant to the given animal species in accordance with the OIE Terrestrial Animal Health Code, including African swine fever during the last 12 months in the territory of the EU Member State or administrative territory according to the EU regionalisation.	
	5.	Animals, from which meat and raw materials intended for the production of final products originate, were not subjected to the administration of natural or synthetical estrogenic, hormonal substances, thyreostatics, antibiotics, other drugs and pesticides used prior to slaughter no later than authorised by instructions on how to use them.	
	6.	The products are recognized as fit for human consumption.	
	7.	Microbiological, chemical-toxicological and radiological characteristics of raw materials of animal origin contained in the products comply with veterinary-sanitary rules and requirements of the EU.	
	8.	Single-use containers and packaging material are intact and correspond to hygienic requirements of the EU.	
	9.	The means of transport comply with the requirements of the EU.
