Part II: Certification	II. Health information		
I, the undersigned State/official veterinarian, certify that:			
1. Canned meat, sausages and other ready for consumption meat products exported from the EU to the Republic of Moldova destined for human consumption were produced in meat processing establishments approved by the competent authority in the EU.			
2. Meat and meat material from which the finished meat products are produced and exported to the Republic of Moldova are obtained from slaughter and processing of clinically healthy animals in establishments approved and under supervision by the competent authority in the EU.			
3. Canned meat, sausages and other ready for consumption meat products are produced in meat processing plants not under restrictions with regard to contagious diseases relevant to the given animal species in accordance with the OIE Terrestrial Animal Health Code.			
4. Meat and meat materials from which the finished meat products are produced are derived from animals that were not subjected to the administration of natural or synthetical estrogenic, hormonal substances, thyreostatics, antibiotics, other drugs and pesticides, used prior to slaughter no later than authorised by instructions on how to use them, and were subjected to post-mortem veterinary inspection by State/official Veterinary Service of the country of origin.			
5. Microbiological, chemical-toxicological and radiological characteristics of the finished meat products comply with veterinary and sanitary rules and requirements according to the EU legislation.			
6. Canned meat, sausages and other meat products are recognized as fit for human consumption.			
7. The products must have identification mark on package. The label carrying the identification mark is placed on package in a way to ensure that opening of the package is impossible without tearing or destroying the label. If the package design prevents it from unauthorized opening, the label is placed on the package so that it cannot be reused.			
8. Single-use containers and packaging material are intact and correspond to hygienic requirements of the exporting country.			
9. The means of transport comply with the requirements of the exporting country.
