The raw milk, which is exported to the Republic of Moldova, described above has been obtained from animals: <ol style="list-style-type: none"> a) under the control of the official veterinary service, b) which were in a country or part thereof that has been free of foot-and-mouth disease and of rinderpest for a period of at least 12 months prior to the date of this certificate, and where vaccination against foot-and-mouth disease has not been carried out during that period, c) belonging to holdings which were not under restrictions due to foot-and-mouth disease or rinderpest, and d) subject to regular veterinary inspections to ensure that they satisfy the animal health requirements of the EU. 2. It comes from holdings registered in accordance with Regulation (EC) No 852/2004 and checked in accordance with Article 49 and Article 50 to Commission Implementing Regulation (EU) 2019/627. 3. It meets the plate and somatic cell count criteria laid down in Annex III to Regulation (EC) No 853/2004. 4. The guarantees on the residues status of raw milk provided by the monitoring plans for the detection of residues or substances submitted in accordance with Regulation (EU) 2017/625. 5. Pursuant to testing for residues of antibacterial drugs carried out by the food business operator in accordance with the requirements of Regulation (EC) No 853/2004, it complies with the maximum residue limits for residues of antibacterial veterinary medicinal products laid down in Commission Regulation (EU) No 37/2010. 6. It has been produced under conditions guaranteeing compliance with the maximum residue levels for pesticides in accordance with the requirements of the EU.
